

## ACCRTA Scholarship Available

The Executive Board of the Arkansas City Clerks, Recorder and Treasurers Association (ACCRTA) awards scholarships for tuition to attend the Municipal Clerks' Training Institute, the Academy for Advanced Education and the International Institute of Municipal Clerks' Annual Conference, all of which will enable Arkansas clerks to further educational training.

A scholarship honors the memory of Bill S. Bonner. It will be awarded only to first-year attendees in the certification program at the Institute; in the amount of tuition only.

There will be five local \$400 scholarships to attend the Certification Section of the Municipal Clerks' Institute in Fayetteville, Sept. 15 - 18, for tuition and lodging; one for the Academy of Advanced Education in Fayetteville, Sept. 17-18, in the amount of \$400 and one \$400 tuition scholarship to attend the International Institute of Municipal Clerks (IIMC) annual conference in Atlanta, Ga. May 18, 2008 - May 22, 2008.

These scholarships are in addition to the 10 regional tuition scholarships awarded by the IIMC.
