Treasures Report

Diane Whitbey presented the expense report for 2022-2023. Whitbey stated 2022-2023 budget there was \$15,756.47 in expenses and \$40,514.65 (\$18,404.44 from the IIMC conference account) in revenue, leaving a difference of \$24,758.18.

On a motion made by Barbara Blackard, seconded by Penny Lamb to accept the Treasurers report as submitted. Motion passed unanimously.

Approval of Minutes

President Timmons presented minutes from meetings held June 15, 2023, business meeting. Motion made by Whitbey and seconded by Blackard motion passed unanimously.

ACCRTA 501 (3)c

Whitbey took the IRS forms to the accountant that helped her with her campaign. The CPA agreed to look over the documents at no charge. Kara Paxton was able to provide the paperwork

where Sondra filed for the non-profit status. The CPA will charge \$200.00 an hour and will only charge when they are talking to ACCRTA. The board agreed before we hired an accountant to complete the filing that an agreement needed to be reached on price. Secretary Bennett suggested setting a limit of \$500.00 and for a Professional Fee line item to be added to the budget.

Motion was made by Vice President McVay, seconded by Barbara Blackard to add \$500.00 to the 2023-2024 budget for a CPA. Motion passed unanimously.

2023-2024 Budget Discussion
